1 Overview of the CRR disclosure requirements

The disclosure of Münchener Hypothekenbank is based on Part 8 of Regulation (EU) No. 575/2013 of the European Parliament and of the Council of 26 June 2013 on prudential requirements for credit institutions and investment firms, amending Regulation (EU) No. 648/2012 (Capital Requirements Regulation, CRR). With effect from 31 March 2025, Regulation (EU) No. 2024/1623 (CRR III), as a revision of Regulation (EU) No. 575/2013, became applicable for the first time and has been taken into account accordingly in the following.

Pursuant to Article 433 CRR, institutions are required to disclose the information set out in Part 8 CRR at least on an annual basis. Münchener Hypothekenbank qualifies as a large institution within the meaning of the CRR, with total assets exceeding EUR 30 billion. As a result, quarterly disclosure in accordance with Article 433a CRR has been in place since 30 June 2021.

The content presented herein is aligned with the technical standards on disclosure as established by Implementing Regulation (EU) No. 2024/3172. All disclosures required under the CRR as at 31 March 2026 are consolidated in this document.

This disclosure report complies with all applicable legal and regulatory requirements and is prepared in accordance with internal policies, procedures, systems, and controls. The Management Board authorises this Pillar III report for publication and confirms that Münchener Hypothekenbank meets the requirements of **Article 431(3) CRR**.

The amounts are presented in million euros. Rounding differences can occur.

The following overview lists the disclosure requirements pursuant to CRR and the corresponding chapters in Münchener Hypothekenbank’s disclosure report.
